

Germany surrendered on May 7th, 1945, and on this same date–seventy-three years later–I write this message for the fourteenth edition of the *Timberwolf HOWL* that we, the NTPA (the children, family, and friends of the Veterans of the 104th Infantry Division of WWII), have had the privilege to bring to you.

The NTPA was established in 2010 with the goal of honoring our WWII Veterans by continuing the NTA traditions that began in 1945 while preserving the history of the 104th for future generations. To fulfill this duty, our dedicated and talented committee of volunteers has been busy with many TW activities over the past eight years. They teleconference monthly to review association business; they organize the annual reunions (and are already at work on 2019); and they engage in longterm planning, which currently includes identifying museums to be the future home(s) of historical collections of TW artifacts. Throughout this period, they have also remained accessible as a resource for TW family and friends to locate specific history regarding a relative or to honor a WWII Veteran.

TW TRACKS IN HISTORY

Lucherberg, Part 2

At daylight, the enemy surrounded the double house in Lucherberg, where most of the remaining men of Company I, 415th Infantry, had taken refuge. To the Germans, it must have looked like curtains for the Americans.

But although the Timberwolves were trapped, they were far from helpless. Two men in the house could save them. Second Lt. John Shipley, who had taken charge when Lt. Varella was captured, was a mortar forward observer from Company M in the 415th Infantry weapons company. Over his radio, Shipley called for mortar fire. A barrage of shells arrived in response, falling to within fifteen yards of the house. The Germans scurried for cover. As soon as they reappeared, Shipley called for mortar fire again. Every time the enemy stuck their heads up, he called on his mortars. When the Germans sought cover by moving closer to the house, the men inside hit them with rifle fire and grenades.

In one of Shipley's many radio conversations with 3d Battalion, when he was asked how he was doing, he responded, "My only trouble is getting a place to see and shoot with all these dead Jerries piling up in front of the cellar windows," and then he asked-again-for reinforcements.

Meanwhile, 1st Lt. Arthur Ulmer, forward observer from the 929th Field Artillery Battalion, was directing artillery fire on the village itself, to force the enemy under cover and prevent the arrival of their reinforcements. Company L, unable to follow Company I across the bridge during the night, was having trouble finding a place to cross. It finally split into two groups: Capt. Francis J. Hallahan, taking the first platoon and the machine gun section, and 1st Lt. Thomas Danowski taking the rest of the company, crossed the river at different locations. They reunited at the coal factory, where they joined Company G.

In response to Shipley's repeated calls for help, Company F was pulled out of reserve. It crossed the river in small groups and joined the others in the factory. Captain Hallahan was placed in command of this composite group.

It was decided that Company G and E (in the nearby castle) would remain where they were to tie down enemy troops in the area. Company L would try to make contact with I Company, and F would move into position to attack the south part of town. Five Timberwolf companies (I, L, G, F, and E) were now trying to capture a village of less than 500 inhabitants. The German army was fighting tooth and nail to hold the line.

Tanks and tank destroyers were desperately needed inside Lucherberg, but every time the engineers went to work on a bridge, they were driven back by enemy artillery fire from across the river. Even setting up a small footbridge was a major task, let alone a bridge large enough to support tanks.

The plan worked out by the Timberwolves in the factory went surprisingly well. In less than twenty minutes, each group was closing in on its objective. Resistance was light,

WRIGHT-PATTERSON NATIONAL MUSEUM of the US AIR FORCE TOUR

Thursday, September 6:

The National Museum of the US Air Force at Wright-Patterson Air Force Base is the oldest and largest military aviation museum in the world. The museum tells the exciting story of aviation development from the days of the Wright brothers at Kitty Hawk to the Space Age. Exhibits include more than 300 aircraft and missiles, plus family-oriented and historically interesting aeronautical displays. The museum also features an IMAX theater showing movies each hour on the hour (the current cost is \$6/senior or \$6.75/adult but is subject to change). Have lunch on your own in the cafeteria on the second level. Buses will shuttle back to the hotel at regularly scheduled intervals.

DAYTON CITY / CARILLON HISTORICAL PARK TOUR Friday, September 7:

The birthplace of aviation, Dayton was once home to poweredflight inventors, Orville and Wilbur Wright. Your guide will narrate the significance of the many interesting sites along this tour, including the Oregon District, the city's oldest suburb; the Civil War Monument; the *Flyover*, an award-winning sculpture of flight; the Korean War State Memorial; and Memorial Hall, where Veterans are honored and remembered. Learn the history of the Miami Valley from the first settlers in 1796 to the influence of such entrepreneurs as Patterson, Deeds, Kettering, and Fraze. These notables and others made immense contributions to aviation, the arts, sports, government, and industry. There will be a short stop at the Esther Price candy store, now a successful candy distributor, which opened fifty years ago in Mrs. Price's basement; then we will stop and visit Carillon Historical Park. Carillon Historical Park celebrates the history of invention, transportation, and pioneer life in Dayton and the Miami Valley. It is home to a variety of collections that document the area's history. While touring the park, you may wish to visit Newcom Tavern, Dayton's oldest standing building; view the Wright Flyer III; and board a 1903 Barney & Smith parlor car. Antique automobiles, a working 1930s print shop, and vintage bicycles are some of the other exhibits you will see along the way. Enjoy lunch on your own at Dayton's upscale shopping and restaurant district, The Greene, which features The Cheesecake Factory, Chipotle, Panera, Subway, and many other dining choices.

presumably because Ulmer kept calling for artillery fire and the Germans were keeping their heads down.

Danowski, now leading L Company, assigned responsibility for a small group of houses to each of the three platoons. Then, in radio contact with Shipley, he worked his way to the double house about seventy-five yards away. While they were discussing plans for the following morning, the Germans moved in and trapped him in the house, where he would spend that night and the next morning.

The night was fairly quiet, though the Timberwolves "sweated out" a counterattack that a captured enemy prisoner had told them was planned for the following morning.

As promised, the counterattack began early the next morning, with about one company of the enemy advancing on the double house with machine guns and mortars. The Americans responded with sniper fire from the upper stories of the house and from other nearby buildings, and Shipley directed mortar fire on the Germans throughout the attack.

An entry in the 415th Infantry Unit Journal at 2200 on 4 December reads: "At 0830 Blue Bn [3d Bn 415] received a counterattack. The enemy, 30 men led by a Captain..." The captain, who turned out to be a 1st lieutenant, "said his attack was not well organized or he would have taken the town. He believed the town was held by one platoon. When told there were two companies in Lucherberg, he merely shrugged his shoulders. A great deal of sniper fire in town, Jerries were in every house not occupied by our men and had to be flushed out."

Later that day, the engineers completed a bridge; and soon, antitank guns, tanks, and tank destroyers were rumbling across to the aid of the beleaguered Timberwolves.

Before daylight on 5 December, the Germans counterattacked—this time, with tanks, assault guns, and about 450 infantry. In the ensuing battle, both sides lost equipment and more men. The fight, which lasted several hours, included mortar and artillery fire, tanks attacks, sniper fire some of everything—from both sides. A 1023 entry in the 415 Unit Journal reads, "Still having trouble in Lucherberg. Given situation and enemy tank that got into town. Enemy air in dog fight with ours."

Although the fighting continued sporadically for several days, the battle for Lucherberg was essentially over. The Timberwolves had taken another town—but at a cost. More than twenty-five men were killed, and many more were wounded and missing.

A HOME FOR THE 104TH? GREAT NEWS!

We are happy to announce that the NTPA is beginning a partnership with Fort Douglas and the University of Utah in Salt Lake City to have a dedicated place in the newly expanded Fort Douglas Military Museum (www. FortDouglas.org) for a display of Timberwolf history, including interactive features. There will also be a database created to easily access TW resources. The museum directors are 100 percent behind this project, and we look forward to working with them.

The 104th has several very important connections with Fort Douglas:

- Fort Douglas is the home of the original 104th Frontier Division, activated June 24, 1921, in Salt Lake City as part of the Organized Reserves.
- Fort Douglas is the original home of the 413th Regiment, which incorporates the Utah seagull as its regimental crest.
- The other two 104th regiments also originated in the Intermountain West—the 414th in Pocatello, Idaho, and the 415th in Casper, Wyoming.
- Fort Douglas is General Terry Allen's birthplace.

• Fort Douglas was a major induction center in WWII for the Intermountain West.

Kathy Clark and I will be visiting the museum sometime this summer to assess what the museum can use, and we need your assistance. If you have documents, artifacts, and so on that you would be willing share, duplicate, or donate, please let one of us know so that we can create a list of what is available (see our contact info in the page 2 board listing).

We do hope that this is the first of several museum displays that we can create, with the others being in Oregon (where the division trained), in the New Orleans National WWII Museum, and elsewhere. This is a fabulous start to our goal to keep the story of the 104th and its important history alive.
